Thanks to Mitch Bennett who's support over the last few months, as a Committee person, is very much appreciated. Dog Torque, on one of their weekly IT sessions, interviewed me. It was an honour and an opportunity to portray the aim, purpose and objectives of the Society. It went alright, but the recording was of poor quality.

The Website www.ausds.org has had misdemeanours rectified, and a sponsorship 'tab' is in place - thanks to Danny Ruben. Also, an acknowledgement that the Society is a Member of the Australian Federation for Livestock Working Dogs has been placed on the Website.

The Australian Utility Stock Dog Society Inc. has achieved quite a few things over the 12 months:

Importantly, the AUSDS Inc. Animal Welfare Policy was formulated and is now in place;

A formula, devised by Deb Maxwell, is now used to transpose the scoring from the Judge's Cards to the large spreadsheet that is displayed for all to see at 'Stock Dog Challenges';

Level 1 was promoted as being a 'low-key' event on the Society's Facebook page;

'Judging Simplified' was also portrayed on the Facebook page;

'Stockmanship Awards' are now presented for both Level 1 and Level 2;

Medallions, as 'minor prizes', are given for the highest score in each of the 4 Aspects of both Level 1 and Level 2;

Total Prize Money has increased by \$200, and a 4th place is now awarded to competitors in Level 2;

The AUSDS Inc. Database for Dog Assessments is up to-date;

New Memberships fees paid during the first half of the calendar year, include payment for next financial year;

Trial Rule 8. a. has been clarified – it is the dog only that is ineligible to enter Level 1 if it has previously won that Level, or an AUSDS Inc. trial at a higher Level; and

56 more dogs have been registered with the Society, totalling just on two hundred.

There are quite a lot of things to attend to:

Unfortunately, Pam Vickery feels that she can't do justice to either of the two roles of Treasurer and Registrar. The Society is seeking new appointments. At present, much of the work load has been undertaken by myself. I consider that the delegation of 'things to do' is not wide spread enough.

More venues for the AUSDS Inc. 'Stock Dog Challenges' needs be sourced, and the arranging of at least another two events during 2022 requires undertaking. Continued momentum is so important.

Level 2 requires further promoting, and I consider that higher prize money, and a major sponsor needs to be looked into.

Once again, it has been an honour representing the Australian Utility Stock Dog Society as President - thank you.
